TARDY & ATTENDANCE POLICY

WHAT IS A TARDY?

WHEN A STUDENT IS NOT PHYSICALLY INSIDE THE CLASSROOM DOOR WHEN THE BELL RINGS.

WHAT DO I DO IF I AM TARDY TO SCHOOL?

IMMEDIATELY REPORT TO THE FRONT OFFICE. YOU WILL BE ISSUED A PASS. IF TARDIES AND ATTENDANCE BECOME EXCESSIVE, PARENT CONTACT WILL BE MADE. CONSEQUENCES MAY FOLLOW INCLUDING BUT NOT LIMITED TO AM/PM/LUNCH DETENTION, RESTRICTED PASSING, ETC.

WHAT DO I DO IF I AM TARDY TO CLASS ?

IMMEDIATELY ENTER THE CLASSROOM, SCAN QR CODE. REFER TO SSMS TARDY POLICY NEXT STEPS.

WHERE IS THE TARDY POLICY LOCATED?

ON OUR SCHOOL WEBSITE UNDER THE STUDENTS TAB, AND POSTED IN CLASSROOMS.

DRESS CODE

WHERE IS THE DRESS CODE POLICY LOCATED?

WHAT DO I DO IF I AM OUT OF DRESS CODE?

A STAFF MEMBER WILL SEND YOU TO STUDENT SERVICES TO PROVIDE CHANGE OF CLOTHES.

WHAT ARE THE CONSEQUENCES FOR DRESS CODE?

1. WARNING, CHANGE OF CLOTHES
2. WARNING, CHANGE OF CLOTHES, PARENT CONTACT
3. CHANGE CLOTHES, PARENT CONTACT, LUNCH DETENTION (1 DAY)
4. CHANGE CLOTHES, PARENT CONTACT, LUNCH DETENTION (3 DAYS)
5. CHANGE CLOTHES, PARENT CONTACT, BEFORE/AFTER SCHOOL DETENTION (1 DAY)
6. CHANGE CLOTHES, PARENT CONTACT, BEFORE/AFTER SCHOOL DETENTION (3 DAYS)
7. REFERRAL

WHEN CAN I USE A WIRELESS COMMUNICATION DEVICE?

LUNCH, BEFORE & AFTER SCHOOL, PASSING, AFTER SCHOOL ACTIVITIES, ON THE SCHOOL BUS, AND WHEN A CLASSROOM TEACHER ALLOWS YOU TO USE IT FOR INSTRUCTION.

CAN A STAFF MEMBER SEARCH OR CONFISCATE MY WIRELESS COMMUNICATION DEVICE?

YES, SEE STUDENT CODE OF CONDUCT PAGE 16 AND 17. THIS CAN BE FOUND ON OUR SCHOOL WEBSITE UNDER STUDENT TAB.

WHAT ARE THE CONSEQUENCES FOR INAPPROPRIATE USE OF WCD?

1. WARNING
2. WARNING AND PARENT CONTACT
3. CONFISCATION, STUDENT PICK UP AT END OF PERIOD
4. CONFISCATION, STUDENT PICK UP AT THE END OF DAY
5. CONFISCATION, STUDENT PICK UP AT THE END OF DAY, AND LUNCH DETENTION
6. CONFISCATION, STUDENT PICK UP AT THE END OF DAY, REFERRAL, PROGRESSIVE DISCIPLINE, CHECK IN CHECK OUT OF DEVICE FOR PERIOD OF TIME

*ADMINISTRATION MAY CREATE CHECK IN CHECK OUT AND/OR WCD STUDENT BEHAVIOR AGREEMENTS THAT WILL LIMIT/ELIMINATE WCD USE, IF NECESSARY
